I am directed to refer the sanction of the President to release an amount of Rs 3,25,00,000/- (Rupees Three Crore Twenty Five Lakhs only) as the 1st installment to be incurred to the State Governments of Andhra Pradesh as Preparatory Grant under Rashtriya Uchchar Shiksha Abhiyan (RUSA) for the year 2013-14. Under the initiative under reference, the Central Government shall provide assistance to the State Government for preparatory activities like Capacity Building, planning etc. under RUSA. The subsequent releases will be dependent on the submission of Utilization Certificate for the earlier grants released.

2. Subject to approval of the competent authority and fulfillment of all conditions MHRD shall release Rs. 3,25,00,000/- (Rupees Three Crore Twenty Five Lakhs only) of the allocation as the first instalment.

3. The sanction is issued in exercise of the powers delegated to Ministries under DFPR, 1978, as amended from time to time. Above grants are being released in accordance with the pattern of Assistance approved by the Ministry of Finance, Government of India. It is also certified that this Sanction is being issued in conformity with the rules and principles of the scheme.

4. On receipt of sanction letter, the Principal Accounts Officer may issue an advice to the Reserve Bank of India (Central Accounts Section), Nagpur for affording credit of the sanctioned amount to the balance of the State Government. The Principal Accounts Officer may forward a copy of the advice to the Accountant General and Finance Department of the State Government as well as Director, Higher Education of the State with a copy to the undersigned. The State will then transfer these amounts along with its matching grant to the RUSA bank account of State Higher Education Council (SHEC).

5. The grant-in-aid is subject to adjustment on the basis of audited statement of accounts of the State Government. Further, the accounts of the SHEC, in so far as it relates to grants-in-aid will be open to inspection by the sanctioning authority and audit both; by the Comptroller & Auditor General of India or by any other designated by him and Internal audit by the Principal Accounts Office of the Ministry of Human Resource Development, Department of Higher Education, whenever it is called upon to do so.

6. The State Government shall maintain an audited record of all assets acquired wholly or substantially out of the scheme grants and these assets shall not, without the prior sanction State Government be disposed of, encumbered or utilized for purposes other than those which grants-in-aid are sanctioned.
