Sir,

I am directed to refer to the approval of the competent authority to release an amount of **Rs.31,44,00,000/- (Rupees Thirty One Crore Forty Four Lakh Only)** as 2<sup>nd</sup> installment of Preparatory Grants, Infrastructure Grants to 2 Universities and 22 Colleges, 3<sup>rd</sup> installment of Infrastructure Grants to 24 Colleges and 3<sup>rd</sup> installment of 2 Model Degree Colleges at the central: state share of 60:40 to be incurred to the State Government of **Andhra Pradesh** under Rashtriya Uchcharat Shiksha Abhiyan (RUSA). Under the initiative under reference, the Central Government shall provide assistance to the State Governments for various components, which are mentioned as per the guidelines under RUSA.

2. In accordance with the instructions of the Department of Expenditure, Ministry of Finance, Government of India, vide **D.O.No.32/PSO/FS/2015 Dated 28<sup>th</sup> October, 2015** for General Category States, the funding pattern is revised to 60:40. **Andhra Pradesh** comes under the General Category States. The 2<sup>nd</sup> installment of Preparatory Grants is **Rs. 2,75,00,000/-**, Infrastructure Grants to 2 Universities is **Rs.12,00,00,000/-** and 22 Colleges is **Rs.9,60,00,000/-**, 3<sup>rd</sup> installment of Infrastructure Grants to 24 Colleges is **Rs.4,32,00,000/-** and 2 Model Degree Colleges is **Rs.2,77,00,000/-**. Further installments of the allocation shall be released by the Ministry only after the State Government concerned releases its committed share towards non-recurring expenditure and recurring grants, besides submission of the Utilisation Certificate by the State in respect of the installment of the Central grant released.

3. The sanction is issued in exercise of the powers delegated to Ministries under DFPR, 1978, as amended from time to time. Above grants are being released in accordance with the pattern of Assistance approved by the Ministry of Finance, Government of India. It is also certified that this Sanction is being issued in conformity with the rules and principles of the scheme.



Sir,

I am directed to refer to the approval of the competent authority to release an amount of **Rs.31,44,00,000/- (Rupees Thirty One Crore Forty Four Lakh Only)** as 2<sup>nd</sup> installment of Preparatory Grants, Infrastructure Grants to 2 Universities and 22 Colleges, 3<sup>rd</sup> installment of Infrastructure Grants to 24 Colleges and 3<sup>rd</sup> installment of 2 Model Degree Colleges at the central: state share of 60:40 to be incurred to the State Government of **Andhra Pradesh** under Rashtriya Uchcharat Shiksha Abhiyan (RUSA). Under the initiative under reference, the Central Government shall provide assistance to the State Governments for various components, which are mentioned as per the guidelines under RUSA.

2. In accordance with the instructions of the Department of Expenditure, Ministry of Finance, Government of India, vide **D.O.No.32/PSO/FS/2015 Dated 28<sup>th</sup> October, 2015** for General Category States, the funding pattern is revised to 60:40. **Andhra Pradesh** comes under the General Category States. The 2<sup>nd</sup> installment of Preparatory Grants is **Rs. 2,75,00,000/-**, Infrastructure Grants to 2 Universities is **Rs.12,00,00,000/-** and 22 Colleges is **Rs.9,60,00,000/-**, 3<sup>rd</sup> installment of Infrastructure Grants to 24 Colleges is **Rs.4,32,00,000/-** and 2 Model Degree Colleges is **Rs.2,77,00,000/-**. Further installments of the allocation shall be released by the Ministry only after the State Government concerned releases its committed share towards non-recurring expenditure and recurring grants, besides submission of the Utilisation Certificate by the State in respect of the installment of the Central grant released.

3. The sanction is issued in exercise of the powers delegated to Ministries under DFPR, 1978, as amended from time to time. Above grants are being released in accordance with the pattern of Assistance approved by the Ministry of Finance, Government of India. It is also certified that this Sanction is being issued in conformity with the rules and principles of the scheme.

Further, the accounts of **Andhra Pradesh** SHEC in so far as it relates to grants-in-aid will be open to inspection by the sanctioning authority and audit both; by the Comptroller & Auditor General of India or by any other designated by him and Internal audit by the Principal Accounts Office of the Ministry of Human Resource Development, Department of Higher Education, whenever it is called upon to do so.

6. The amount is debitable to the following three Heads of Demand No.58-Department of Higher Education:

The Expenditure of **Rs.2,35,80,000/- (Rupees Two Crore Thirty Five Lakh Eighty Thousand Only)** will be debited to Demand No.58-Department of Higher Education from : Major Head 3601 Grants-in-aid to State Government, 06- Centrally Sponsored Schemes 796- Tribal Area Sub Plan, 33-National Education Mission: Rashtriya Uchchar Shiksha Abhiyan (RUSA), 01- Rashtriya Uchchar Shiksha Abhiyan (RUSA), 31-Grants-in-aid-General, of the financial year 2017-18.
