This scheme has now been subsumed under Rashtriya Uchchatar Shiksha Abhiyan (RUSA).

Under RUSA, the Central Government shall provide assistance to the extent of 90% (in NER, J&K, Uttarakhand and Himachal Pradesh) and 65% of the capital cost for establishment of each Model Degree College. The capital cost can be up to an amount of Rs. 12.00 crore for each college. The recurring expenditure will be borne by the State. Since Andhra Pradesh does not come under the Special Category States, the ratio of Centre to State share in the grants is 65:35 and the Centre will provide upto Rs. 7.80 crores per college. The first instalment is 50% of the Centre Share i.e. Rs. 3.90 crore per college. The subsequent releases will be dependent on the submission of Utilization Certificate for the earlier grants released.
- 3. Subject to approval of the competent authority and fulfillment of all conditions as per RUSA norms, MHRD shall release Rs 25,55,80,000/- of the allocation as the first instalment. Further instalments of the allocation shall be released by the Ministry only after the State Government concerned releases 50% of its committed share towards non-recurring expenditure and recurring grant, besides submission of the Utilisation Certificate by the College in respect of the first installment of the grant released.
