Sub:- Release of Grants to **Andhra Pradesh** as Infrastructure Grants to 1 University and 43 Colleges under Rashtriya Uchchatar Shiksha Abhiyan (RUSA).

Sir.

I am directed to refer to the approval of the competent authority to release an amount of Rs.13,25,00,000/- (Rupees Thirteen Crore Twenty Five Lakhs Only) as the 1st installment to be incurred to the State Government of Andhra Pradesh as Infrastructure Grants to 1 University and 43 Colleges, under Rashtriya Uchchatar Shiksha Abhiyan (RUSA) subject to fulfillment of all conditions as per RUSA norms. Under the initiative under reference, the Central Government shall provide assistance to the State Governments for various components, which are mentioned as per the guidelines under RUSA.

- 2. Pending final decision on the Centre State funding pattern for CSS schemes, in view of the larger devolution of tax resources to States as per the recommendations of 14<sup>th</sup> Finance Commission, the sharing pattern for this release is being modified to 50:50 basis, in accordance with the instructions of the Department of Expenditure, Ministry of Finance, Government of India, for General Category States. Andhra Pradesh comes under the General Category States. The first installment is of the Centre share as grants for Infrastructure to 1 University is Rs.2,50,00,000/- and Infrastructure to 43 Colleges is Rs.10,75,00,000/-. Further installments of the allocation shall be released by the Ministry only after the State Government concerned releases its committed share towards non-recurring expenditure and recurring grants, besides submission of the Utilisation Certificate by the State in respect of the installment of the Central grant released.
- 3. The sanction is issued in exercise of the powers delegated to Ministries under DFPR, 1978, as amended from time to time. Above grants are being released in accordance with the pattern of Assistance approved by the Ministry of Finance, Government of India. It is also certified that this Sanction is being issued in conformity with the rules and principles of the scheme.
- 4. On receipt of sanction letter, the Principal Accounts Officer may issue an advice to the Reserve Bank of India (Central Accounts Section), Nagpur for affording credit of the sanctioned amount to the balance of the State Government. The Principal Accounts Officer may forward a copy of the advice to the Accountant General and Finance Department of the State Government as well as Director, Higher Education of the State with a copy to the

undersigned. The State will then transfer these amounts along with its matching grant to the

RUSA bank account of State Higher Education Council (SHEC).

5. The grant-in-aid is subject to adjustment on the basis of audited statement of accounts of **Andhra Pradesh**. Further, the accounts of **Andhra Pradesh** SHEC in so far as it relates to grants-in-aid will be open to inspection by the sanctioning authority and audit both; by the Comptroller & Auditor General of India or by any other designated by him and Internal audit by the Principal Accounts Office of the Ministry of Human Resource Development, Department of Higher Education, whenever it is called upon to do so.

- 6. The amount is debitable to the following three Heads of Demand No.60-Department of Higher Education:
  - I. Rs.10,26,87,500/- (General) from: Major Head 3601 Grants in aid to state Govt, 04-Grants to Centrally Sponsored Plan Schemes 189- University and Higher Education, 02-General (General Education)- Other Grants, 01-Rashtriya Uchchatar Shiksha Abhiyan (RUSA), 31- Grant in Aid, of the financial year 2015-16 (Plan).
  - II. Rs.1,98,75,000/- (SC) from: Major Head 3601 Grants in aid to state Govt, 04-Grants to Centrally Sponsored Plan Schemes 789- Special Component Plan for Schedule Castes, 43- General Education, 02- Rashtriya Uchchatar Shiksha Abhiyan (RUSA), 31- Grant in Aid, of the financial year 2015-16 (Plan).
  - III. Rs.99,37,500/- (ST) from: Major Head 3601 Grants in aid to state Govt, 04-Grants to Centrally Sponsored Plan Schemes 796- Tribal Area Sub Plan, 09-General Education, 02- Rashtriya Uchchatar Shiksha Abhiyan (RUSA), 31- Grant in Aid, of the financial year 2015-16 (Plan).
- 7. Accordingly, I am directed to convey the sanction of the President to release an amount of Rs.99,37,500/- (Rupees Ninety Nine Lakhs Thirty Seven Thousand Five Hundred Only) as the ST Component of the 1<sup>st</sup> installment to be incurred to the State Government of Andhra Pradesh as Infrastructure Grants to 1 University and 43 Colleges under Rashtriya Uchchatar Shiksha Abhiyan (RUSA).
- 8. The Expenditure Rs.99,37,500/- (Rupees Ninety Nine Lakhs Thirty Seven Thousand Five Hundred Only) will be debited to Demand No.60-Department of Higher Education from Major Head 3601 Grants in aid to state Govt, 04-Grants to Centrally Sponsored Plan Schemes 796- Tribal Area Sub Plan, 09- General Education, 02- Rashtriya Uchchatar Shiksha Abhiyan (RUSA), 31- Grant in Aid, of the financial year 2015-16 (Plan).
- 9. A certificate of actual utilization of the grants received, for the purpose for which it was received, should be submitted to the Ministry within 12 months of the closures of the financial year.
- 10. The grant has been sanctioned in accordance with the pattern approved by the Ministry of Finance and is in conformity with the rules and principles of the scheme as approved by the Ministry of Finance.
- 11. Necessary Sanction ID has been generated.
- 12. This sanction issues with the concurrence of Integrated Finance Division's Dy. No.2691/2015, dated 23.09.2015 and funds certified by the IF I Section vide their Dy.No.615/15-IF.I dated 29.09.2015.
