I am directed to refer to the approval of the competent authority to release an amount of **Rs.26,95,00,000 /- (Rupees Twenty Six Crore Ninety Five Lakhs Only)** as 1st instalment to Creation of 1 Cluster University, 1st instalment to Upgradation of 2 Colleges to MDCs, 1st instalment for infrastructure grants to 1 University and 2nd instalment to 2 New MDCs at the central : state share of 60:40 to be incurred to the State Government of **Andhra Pradesh** under Rashtriya Uchchatar Shiksha Abhiyan (RUSA). Under the initiative under reference, the Central Government shall provide assistance to the State Governments for various components, which are mentioned as per the guidelines under RUSA.

2. In accordance with the instructions of the Department of Expenditure, Ministry of Finance, Government of India, vide **D.O.No.32/PSO/FS/2015 Dated 28th October, 2015** for General Category States, the funding pattern is revised to 60:40. **Andhra Pradesh** comes under the General Category States. 1st instalment to Creation of 1 Cluster University, 1st instalment to Upgradation of 2 Colleges to MDCs, 1st instalment for infrastructure grants to 1 University and 2nd instalment to 2 New MDCs at the central : state share of 60:40 to be incurred to the State Government of **Andhra Pradesh** under Rashtriya Uchchatar Shiksha Abhiyan (RUSA) amounts to **Rs.26,95,00,000 /- (Rupees Twenty Six Crore Ninety Five Lakhs Only)**. Further installments of the allocation shall be released by the Ministry only after the State Government concerned releases of its committed share towards non-recurring expenditure and recurring grants, besides submission of the Utilisation Certificate by the State in respect of the first installment of the grant released.

3. The sanction is issued in exercise of the powers delegated to Ministries under DFPR, 1978, as amended from time to time. Above grants are being released in accordance with the pattern of Assistance approved by the Ministry of Finance, Government of India. Sir,

I am directed to refer to the approval of the competent authority to release an amount of **Rs.26,95,00,000 /- (Rupees Twenty Six Crore Ninety Five Lakhs Only)** as 1st instalment to Creation of 1 Cluster University, 1st instalment to Upgradation of 2 Colleges to MDCs, 1st instalment for infrastructure grants to 1 University and 2nd instalment to 2 New MDCs at the central : state share of 60:40 to be incurred to the State Government of **Andhra Pradesh** under Rashtriya Uchchatar Shiksha Abhiyan (RUSA). Under the initiative under reference, the Central Government shall provide assistance to the State Governments for various components, which are mentioned as per the guidelines under RUSA.

2. In accordance with the instructions of the Department of Expenditure, Ministry of Finance, Government of India, vide **D.O.No.32/PSO/FS/2015 Dated 28th October, 2015** for General Category States, the funding pattern is revised to 60:40. **Andhra Pradesh** comes under the General Category States. 1st instalment to Creation of 1 Cluster University, 1st instalment to Upgradation of 2 Colleges to MDCs, 1st instalment for infrastructure grants to 1 University and 2nd instalment to 2 New MDCs at the central : state share of 60:40 to be incurred to the State Government of **Andhra Pradesh** under Rashtriya Uchchatar Shiksha Abhiyan (RUSA) amounts to **Rs.26,95,00,000 /- (Rupees Twenty Six Crore Ninety Five Lakhs Only)**. Further installments of the allocation shall be released by the Ministry only after the State Government concerned releases of its committed share towards non-recurring expenditure and recurring grants, besides submission of the Utilisation Certificate by the State in respect of the first installment of the grant released.

3. The sanction is issued in exercise of the powers delegated to Ministries under DFPR, 1978, as amended from time to time. Above grants are being released in accordance with the pattern of Assistance approved by the Ministry of Finance, Government of India. It is also certified that this Sanction is being issued in conformity with the rules and principles of the scheme.

Further, the accounts of **Andhra Pradesh SHEC** in so far as it relates to grants-in-aid will be open to inspection by the sanctioning authority and audit both; by the Comptroller & Auditor General of India or by any other designated by him and Internal audit by the Principal Accounts Office of the Ministry of Human Resource Development, Department of Higher Education, whenever it is called upon to do so.

6. The amount is debitible to the following three Heads of Demand No.58-Department of Higher Education:


