Sir,

I am directed to refer to the approval of the competent authority to release an amount of **Rs.28,03,30,000/- (Rupees Twenty Eight Crore Three Lakh Thirty Thousand Only)** as 2nd installment of 2 New Model Degree Colleges, Infrastructure Grants to 1 University and 34 Colleges at the central: state share of 60:40 to be incurred to the State Government of **Andhra Pradesh** under Rashtriya Uchcharat Shiksha Abhiyan (RUSA). Under the initiative under reference, the Central Government shall provide assistance to the State Governments for various components, which are mentioned as per the guidelines under RUSA.

2. In accordance with the instructions of the Department of Expenditure, Ministry of Finance, Government of India, vide **D.O.No.32/PSO/FS/2015 Dated 28th October, 2015** for General Category States, the funding pattern is revised to 60:40. **Andhra Pradesh** comes under the General Category States. The second installment of the central share as 2 New Model Degree Colleges is **Rs.2,83,30,000/-**, Infrastructure Grants to 1 University is **Rs.6,00,00,000/-** and 34 Colleges is **Rs.19,20,00,000/-**. Further installments of the allocation shall be released by the Ministry only after the State Government concerned releases its committed share towards non-recurring expenditure and recurring grants, besides submission of the Utilisation Certificate by the State in respect of the installment of the Central grant released.

3. The sanction is issued in exercise of the powers delegated to Ministries under DFPR, 1978, as amended from time to time. Above grants are being released in accordance with the pattern of Assistance approved by the Ministry of Finance, Government of India. It is also certified that this Sanction is being issued in conformity with the rules and principles of the scheme.

4. On receipt of sanction letter, the Principal Accounts Officer may issue an advice to the Reserve Bank of India (Central Accounts Section), Nagpur for affording credit of the sanctioned amount to the balance of the State Government. The Principal Accounts Officer may forward a copy of the advice to the Accountant General and Finance Department of the State Government as well as Director, Higher Education of the State with a copy to the undersigned. The State will then transfer these amounts to the RUSA bank account of State Higher Education Council (SHEC).

5. The grant-in-aid is subject to adjustment on the basis of audited statement of accounts of **Andhra Pradesh**. 




