Sir,

I am directed to refer to the approval of the competent authority to release an amount of **Rs.19,20,00,000/- (Rupees Nineteen Crore Twenty Lakh Only)** as 1<sup>st</sup> installment of Enhancing Quality and Excellence in select Autonomous College, 2 New Model Degree Colleges and Infrastructure Grants to 15 Colleges at the central: state share of 60:40 to be incurred to the State Government of **Andhra Pradesh** under Rashtriya Uchcharat Shiksha Abhiyan (RUSA). Under the initiative under reference, the Central Government shall provide assistance to the State Governments for various components, which are mentioned as per the guidelines under RUSA.

2. In accordance with the instructions of the Department of Expenditure, Ministry of Finance, Government of India, vide **D.O.No.32/PSO/FS/2015 Dated 28<sup>th</sup> October, 2015** for General Category States, the funding pattern is revised to 60:40. **Andhra Pradesh** comes under the General Category States. The funds being released are 1<sup>st</sup> installment of Enhancing Quality and Excellence in select Autonomous College is **Rs.3,00,00,000/-**, 2 New Model Degree Colleges is **Rs.7,20,00,000/-** and Infrastructure Grants to 15 Colleges is **Rs.9,00,00,000/-** at the central: state share of 60:40 to be incurred to the State Government of Andhra Pradesh under Rashtriya Uchcharat Shiksha Abhiyan (RUSA). Further installments of the allocation shall be released by the Ministry only after the State Government concerned releases its committed share towards non-recurring expenditure and recurring grants, besides submission of the Utilisation Certificate by the State in respect of the installment of the Central grant released.

3. The sanction is issued in exercise of the powers delegated to Ministries under DFPR, 1978, as amended from time to time. Above grants are being released in accordance with the pattern of Assistance approved by the Ministry of Finance, Government of India. It is also certified that this Sanction is being issued in conformity with the rules and principles of the scheme.

4. On receipt of sanction letter, the Principal Accounts Officer may issue an advice to the Reserve Bank of India (Central Accounts Section), Nagpur for affording credit of the sanctioned amount to the balance of the State Government. The Principal Accounts Officer may forward a copy of the advice to the Accountant General and Finance Department of the State Government as well as Director, Higher Education of the State with a copy to the undersigned. The State will then transfer these amounts to the RUSA bank account of State Higher Education Council (SHEC).

5. The grant-in-aid is subject to adjustment on the basis of audited statement of accounts of **Andhra Pradesh**. 



The funds being released are 1<sup>st</sup> installment of Enhancing Quality and Excellence in select Autonomous College is **Rs.3,00,00,000/-**, 2 New Model Degree Colleges is **Rs.7,20,00,000/-** and Infrastructure Grants to 15 Colleges is **Rs.9,00,00,000/-** at the central: state share of 60:40 to be incurred to the State Government of Andhra Pradesh under Rashtriya Uchchar Shiksha Abhiyan (RUSA). Further installments of the allocation shall be released by the Ministry only after the State Government concerned releases its committed share towards non-recurring expenditure and recurring grants, besides submission of the Utilisation Certificate by the State in respect of the installment of the Central grant released.

3. The sanction is issued in exercise of the powers delegated to Ministries under DFPR, 1978, as amended from time to time. Above grants are being released in accordance with the pattern of Assistance approved by the Ministry of Finance, Government of India. It is also certified that this Sanction is being issued in conformity with the rules and principles of the scheme.

4. On receipt of sanction letter, the Principal Accounts Officer may issue an advice to the Reserve Bank of India (Central Accounts Section), Nagpur for affording credit of the sanctioned amount to the balance of the State Government. The Principal Accounts Officer may forward a copy of the advice to the Accountant General and Finance Department of the State Government as well as Director, Higher Education of the State with a copy to the undersigned. The State will then transfer these amounts to the RUSA bank account of State Higher Education Council (SHEC).

5. The grant-in-aid is subject to adjustment on the basis of audited statement of accounts of **Andhra Pradesh**. Further, the accounts of **Andhra Pradesh** SHEC in so far as it relates to grants-in-aid will be open to inspection by the sanctioning authority and audit both; by the Comptroller & Auditor General of India or by any other designated by him and Internal audit by the Principal Accounts Office of the Ministry of Human Resource Development, Department of Higher Education, whenever it is called upon to do so.
