I am directed to refer to the approval of the competent authority to release an amount of **Rs.19,80,00,000/- (Rupees Nineteen Crore Eighty Lakh Only)** as 1<sup>st</sup> installment for Infrastructure Grants to 2 Universities and Infrastructure Grants to 13 Colleges at the central: state share of 60:40 to be incurred to the State Government of **Andhra Pradesh** under Rashtriya Uchcharat Shiksha Abhiyan (RUSA). Under the initiative under reference, the Central Government shall provide assistance to the State Governments for various components, which are mentioned as per the guidelines under RUSA.

2. **Andhra Pradesh** comes under the General Category State, the funding pattern is 60:40. The funds being released are 1<sup>st</sup> installment for Infrastructure Grants to 2 Universities is **Rs.12,00,00,000/-** and Infrastructure Grants to 13 Colleges is **Rs.7,80,00,000/-** at the central: state share of 60:40 to be incurred to the State Government of Andhra Pradesh under Rashtriya Uchcharat Shiksha Abhiyan (RUSA). Further installments of the allocation shall be released by the Ministry only after the State Government concerned releases its committed share towards non-recurring expenditure and recurring grants, besides submission of the Utilisation Certificate by the State in respect of the installment of the Central grant released.

3. The sanction is issued in exercise of the powers delegated to Ministries under DFPR, 1978, as amended from time to time. Above grants are being released in accordance with the pattern of Assistance approved by the Ministry of Finance, Government of India. It is also certified that this Sanction is being issued in conformity with the rules and principles of the scheme.

4. On receipt of sanction letter, the Principal Accounts Officer may issue an advice to the Reserve Bank of India (Central Accounts Section), Nagpur for affording credit of the sanctioned amount to the balance of the State Government. 9. A certificate of actual utilization of the grants received, for the purpose for which it was received, should be submitted to the Ministry within 12 months of the closure of the financial year.


