Minutes of the 3rd PAB held on 19th November, 2024 under the Chairmanship of Secretary (HE), MoE

The 3rd PAB meeting of Pradhan Mantri Uchchatar Shiksha Abhiyan (PM-USHA) was held on 19th November, 2024 under the Chairmanship of Secretary (HE), MoE, through Video-Conference. The list of participants is at **Annexure-1** (a) & 1 (b).

2. The meeting started with welcome address by Adviser (Cost) followed by a brief of 1st and 2nd PAB meetings of PM-USHA. Additional Secretary (E) also welcomed all the members of PAB.

Adviser (Cost) shared that the proposals of the three States i.e. Bihar, Kerala and Odisha that have onboarded PM-USHA would be considered in the current meeting and the progress of various projects of RUSA 1.0 and 2.0 along with other agenda items would be discussed. The details of available slots under various components are as under:

Decisions taken in the meeting are given as under.

Item No. 1: Review of various slow-moving projects approved under RUSA & Diversion of project to some other Departments in the State/ UT or other institution type

The progress of the 36 projects (Annexure – 1A of Agenda) having physical progress of 50% and below under RUSA 1.0 and 12 projects (Annexure – 1B of Agenda) having physical progress of 25% and below under RUSA 2.0 was discussed.

The diversion of project to some other Departments in the State/UT or other institution type has been observed which was not in line with the objectives of the scheme. The identified projects from the State of Odisha have been digitally launched by the Hon'ble Prime Minister in 2019. Decision for these projects (in Annexure I(C) of Agenda) was sought from PAB.

Decision: PAB was apprised that the progress of the States/UTs is reviewed on a regular basis by the Ministry. Despite of regular monitoring and continuous follow up with the States/UTs, it is observed that some of the projects are slow-moving (in Annexure I(A) & I(B) of Agenda). Based on the discussion/deliberations about the progress of the projects in the meeting, it was decided by the PAB to get a report from the concerned States/ UTs indicating reasons for delay of the Slow-moving projects and commitment to complete them. On the basis of the justification provided by the States/ UTs, decision about cancellation or continuation of projects will be taken by the PAB.

The State of Odisha was asked to submit a detailed report for the projects mentioned in Annexure I(C) of Agenda, where change in use of completed projects has been done. Based on the report, further decision would be taken.

Item No. 2: Presentation on PM-USHA Portal regarding development of modules viz. RUSA Progress Monitoring Module, Fund Proposal Module, PM USHA Progress Monitoring Module and Proposal Revision Monitoring Module, etc.

A brief presentation about the different modules of the PM-USHA portal was made by the NIC Team. PAB appreciated the efforts made by the Ministry in digitizing the process of Proposal submission and evaluation and monitoring of the progress of the projects under the scheme.

Item No. 3: Approval for cancellation of projects in various States/ UTs as per their requests

Based on the requests of various States/ UTs and the justifications furnished thereto, certain projects under RUSA and PM-USHA that were cancelled with the approval of Secretary (HE) & Chairman, PAB, was placed for approval before the PAB.

Decision: After considering the requests made by the States, PAB ratified the cancellation of the projects as per details given in **Annexure-2**.

Item No. 4: Approval of PAB for revisions undertaken by States/ UTs in PM-USHA approved projects

During the 1st PAB meeting of PM-USHA, it was observed that some of the proposals of the States/ UTs, were skewed more towards infrastructure creation and renovation. Similarly, the 2nd PAB observed that some of the GIEI proposals of the States/ UTs, were skewed more towards soft component. Similarly, under GSC component, the States were requested to focus more on creation of labs, procurement of necessary

equipment, etc. Therefore, the States were allowed to revise and align the proposals with the scheme objectives without breaching the financial approval given by the PAB. The States submitted the revised proposals on the Portal along with the Detailed Project Reports (DPRs), which was placed before the PAB for approval.

Further, some of the States/UTs that are Chhattisgarh, Gujarat, Haryana, Jammu & Kashmir, Jharkhand and Uttar Pradesh had not yet submitted the approved DPRs on the portal. This was deliberated and placed before PAB for its consideration.

Decision: In view of the decision of the PAB, the changes made to the Proposals of the previously approved projects (in the 1st and 2nd PAB meetings) were ratified by the PAB. Also, the States were requested to accelerate the process of approval of DPR by their competent authority and expedite the implementation of the projects.

Item No. 5: Proposals submitted by the States of Bihar, Kerala and Odisha under the three components viz. Multi- disciplinary Education and Research Universities (MERU), Grants to Strengthen Universities (GSU) and Grants to Strengthen Colleges (GSC) of PM-USHA Scheme.

The State of Bihar, Kerala and Odisha made presentation of the submitted proposals before the PAB.

Decision: After considering the State-wise proposals, the PAB approved the proposals of three components of MERU, GSU and GSC as per details given in **Annexure-3**, **Annexure-4** and **Annexure-5** respectively.

Item No. 6 and 7: Approval of projects for the component New Model Degree College (NMDC) from the proposals received on the portal & Approval of projects for Gender Inclusion and Equity Initiatives (GIEI) component from the proposals received on the portal.

Based on the proposals received earlier, the proposals that satisfied the eligibility criteria for NMDCs (Annexure-6 of Agenda) were placed before the PAB.

Decision: Under NMDC component, PAB approved 8 eligible proposals as per details given in **Annexure- 6** and it was decided by the PAB that the remaining 32 slots of NMDC are converted to 48 slots of GIEI and are approved accordingly as per details given in **Annexure-7**.

Item No. 8: Approval of the remaining units subsequent to approvals under Agenda item no. 5 under the components of Multi- disciplinary Education and Research Universities (MERU), Grants to Strengthen Universities (GSU) and Grants to Strengthen Colleges (GSC) from the proposals received on the Portal against their respective targets

It was proposed before the PAB that after the approval of projects of the newly onboarded States i.e. Bihar, Kerala and Odisha; the remaining slots may be filled from the already submitted proposals by other States on PM-USHA portal during 1st and 2nd PAB meeting.

Decision: After considering the State-wise proposals, the PAB approved the proposals of the components of GSU and GSC as per details given in **Annexure-8** and **Annexure-9**, respectively.

The meeting ended with a vote of thanks to the Chair.
